We hope this update finds you well. We wanted to notify you, that at this time, all of our residents are COVID free, however we have a staff member that did test positive for COVID-19. This person is not working in the building, at this

time. The department of health is aware, and we are working closely with them. At this time, we will continue testing the staff weekly, and screening all staff for COVID-19 symptoms before start of their work and we will now test every resident in the facility weekly until further notice.

As has been our protocol for this entire time, if your loved one tests positive or has any symptoms of COVID-19, we will notify the primary contact immediately to make them aware and the resident will immediately be moved to the COVID-19 or Persons under investigation unit. We continue to be vigilant with monitoring all residents for symptoms as well as monitoring their vitals.

At this time outside visitation will continue unless you are notified otherwise. We want to remind you that our protocol for appointments continues unchanged. If a resident goes out of the building for any reason, they must be transported via ambulance to that appointment and upon return they will be monitored closely and will be placed in transmission-based precaution. They will be tested for COVID-19 testing following the protocol. There is no exception to this policy.

To Summarize what we continue to do: We continue to work closely with the local Health Department and will continue to follow CMS and CDC guidelines. We also continue to take this very seriously and will take all precautions necessary. We continue to do the following:
